TOURNAMENT RULES

- NAGVA/USAV rules apply
- Line up sheets must be updated with added/removed players. Uniform numbers must be listed on the sheet. The Regional Commissioners and/or Tournament Director reserve the right to charge a team a time out to make sure these are updated.
- Line up sheets will be distributed at the captains meeting on Saturday and at the Command Center on Sunday.
- All players must be signed in on the waiver before playing a point. Teams that do not comply may forfeit each match they played with any unsigned players. The Regional Commissioners and/or Tournament Director reserve the right to charge a team a time out to make sure waivers are signed.
- All uniforms must have numbers clearly visible on the front and back.
- All teams must have a separate certified referee & scorekeeper. These exams may be taken on the NAGVA website. Failure to have these will cost \$30/reffing assignment per position needed.
- Team Reps are responsible for ensuring non-rated players are the skill level (or below) of the division in which they register. Teams will not be allowed to shift divisions.
- The player playing the ball is the only one who may move the dividing curtain out of the way. All overhead obstructions are in play.
- Vertical backboards at Queens College, and the end backboards at Bayard Rustin, are at the discretion of the referee. Side backboards at Bayard Rustin are out.
- You may play the ball to the sideline of the adjacent court. However, a player may not enter the adjacent court at any time.
- Hats are not allowed to be worn during warm-ups/play.
- Players are not permitted to wear headphones or be on their phones during reffing assignments.
- Amplified music is not allowed at any time.

POOL PLAY

All pool play takes place on Saturday. Teams will play four matches consisting of two 25-point sets per match starting at 4-4, with a 27-point cap and two time-outs allowed per team per set.

All pool play matches will be timed by a universal clock. Consequently, matches throughout the gym will begin and end at the same time. Teams will be allowed a warm-up period before each match and allotted a specified amount of time to play both sets. Teams will be signaled at the beginning and end of each match. Teams will need to monitor their 5-minute warm up period and start play on time. The clock will not stop between the first and second set. A three-minute warning will be given toward the end of each match. After this warning, no time-outs may be taken, however, substitutions will be allowed. If play is in progress when the end-of-match signal is given, the point will be played until the ball is dead. The set may not end in a tie.

Forfeits will be strictly enforced according to Standard USA Volleyball rules if a playing team is not ready when a match is scheduled to begin. If the assigned working team is not present and ready to start a match, they will forfeit the first set of their next match, inclusive of Double Elimination rounds. The Standard USA Volleyball substitution rule will be in effect.

Teams **MUST** verify their scores before leaving the gym. Errors found after leaving the gym will not be accepted and the results of pool play will stand.

PROTESTS

Protests must be lodged by the end of the match and noted on the scoresheet at the time of the incident. The protest committee will decide upon the protest at the conclusion of the match. Any delay will forfeit the protest.

ELIMINATION PLAY

Winner's Bracket

All Winner's Bracket matches (including championship matches) are best two-out-of-three sets, no time limit (win by 2-points/cap at 27). The first two sets are 25-point sets starting at 4-4, and, if a third set is needed, a 15-point set starting at 0-0 will be played (win by 2 points/no cap). If, after a championship match, both teams have lost one match, one 25-point set will be played with no time limit and no cap to decide the championship.

Loser's Bracket

All Loser's Bracket matches are one 25-point set starting at 0-0 (win by 2-points/no cap).

PROTESTS

Any protest during elimination play must be noted on the score sheet at the time of the incident and play will stop. The protest committee will convene and make a decision immediately. Any delay will forfeit the protest.

SCHEDULE

The Site Manager and/or Tournament Director reserve the right to reschedule matches to other courts in order to keep the tournament on schedule. In the event of such rulings, teams will be given as much advance notice as possible.
